# TERMS & CONDITIONS

# All Military Vehicle Entrants

On arrival please report to our booking in tent, ensure your vehicle ticket with your entry number is appropriately attached to your vehicle on arrival. Please follow the directions / instructions of our marshal's.

#### Re-Enactors / Stall Holders

On arrival please report to the booking in tent, you will then be allocated a marshal who will guide you to your allocated area.

#### Wrist Bands for Exhibitors

These will be issued on arrival to each individual. Please ensure these are worn by yourself and other members of you group at all times.

## Arrival for Exhibitors and Traders

You may start arriving as of Thursday before the show; departure must be by Tuesday following the show unless previously arranged. Those who are travelling on to the Victory show are welcome to stay until Friday, please advise upon arrival.

#### Camping

There is public camping on site for non-exhibitors; you may start arriving as of Friday 25<sup>th</sup> August. We also ask that any non-military tents and vehicles are removed from the show area by 09:00 each morning. Exhibitors are welcome to use the public camping area for non-military tents and caravans.

### Fuel

There is to be no fuelling of vehicles whatsoever on site, your nearest petrol station is in Dunchurch Village Centre (I mile), however please check the access to station beforehand.

# Dogs

Dogs are allowed on site but please ensure they are kept on a lead and cleaned up after.

# Vehicle Movement

We ask that vehicle movement is kept to a minimum during show times (10:00 to 17:00). Only persons licensed to drive may operate vehicles. Children may not ride motorcyles or quads during the show days. A **5** M.P.H. speed limit is applied within the showground. No unauthorised moving of vehicles during events. Drivers are to obey instructions from Officials and their Assistants. Under section 1, 2 and 3 as amended by the Road Traffic Act of 1991 you could be prosecuted for driving recklessly at this type of event.

## Armoured Vehicle Movement

All movement through the site must be with at least one escort person on foot in front of the vehicle wearing high visibility attire. The 5 M.P.H. speed limits apply unless you are in the Arena where 15 M.P.H. applies. All passengers to be seated in appropriate seats, not on vehicle turrets. Under section 1, 2 and 3 as amended by the Road Traffic Act of 1991 you could be prosecuted for driving recklessly at this type of event if it was considered you have endangered the lives of other exhibitors or members of the public.

# Weapons

Only vehicle mounted weapons or those, as part of a static display will be allowed on site. These must remain secure at all times and must comply with current H. M. Govt. regulations. No weapons are to be carried around on the site. NO BLANK ROUNDS or PYROTECHNICS may be brought on site unless pre-arranged with the organiser.

#### Terms and Conditions cont.

#### Uniforms

There are no objections to the wearing of ALLIED uniforms, providing no decorations or badges of rank are worn to which the wearer is not entitled. AXIS uniforms may be worn as part of a static display or an arena event, but not around the site.

# Arena Events

We hope that you will take part in our arena events. It is a great opportunity for you to display your vehicle in action in front of vast admiring crowds. Full details of the arena events will be available on your arrival.

## Car Parking

Cars will be towed to the parking area if still on the display area after 9:30am. The only exception will be disabled persons vehicles displaying a current blue badge. You are welcome to use your bicycles to move about the site, if ridden with care. Children may not ride motorcycles or quads during the show days.

## Vehicle & Camping Security

This show is open to the general public and they will therefore have access to your vehicle. The organisers can accept no responsibility for loss of, or damage to, your vehicle or its contents.

#### Litter

So as to ensure you are invited back next year, it would be very much appreciated if you would place your litter in the litter bins/skips provided, or take it home with you.

## Barbecues / Fires

To be used only when adequate fire-fighting equipment is available. It is suggested that all vehicles carry a current working fire extinguisher. Open fire must be contained within a steel enclosure

#### Generators

Must conform to the current Health and Safety Regulations and the Electricity at Work Regulations. This includes ground spikes (earthing). Any cost incurred ensuring that your generator complies with current legislations will be at your own expense.

# Privately owned Vehicles

Please note that bikes and quad bikes must have a valid insurance, Tax and MOT (if applicable) and must abide by the **5** M.P.H. speed limit at all times.

Push bikes must have lights in the hours of darkness and children under the age of 14 years must be accompanied by a responsible adult.

Anyone who does not abide by the rules will be asked to leave the showground.

## Exhibitors Vehicles.

All vehicles driven on the road to the site must have a valid insurance, Tax and MOT (if applicable) and must abide by the **5** M.P.H. speed limit at all times
